ADOPTIONS: THE SOUTHERN OREGON HUMANE SOCIETY CONTINUES TO MAINTAIN ONE OF THE HIGHEST ADOPTION RATES IN THE COUNTRY - 1,166 TOTAL ADOPTIONS FOR 2023. THE ANIMALS THAT FOUND NEW HOMES CONSTITUTE AN OVERALL 99% ADOPTION RATE. THROUGH THE SAVING TRAIN PROGRAM, THE SOCIETY SAVES MORE LIVES BY ACCEPTING ANIMALS FROM SHELTERS AND ANIMAL CONTROL AGENCIES ACROSS OREGON AND CALIFORNIA. THESE SHELTERS USUALLY FACE THE DUAL PROBLEM OF TOO MANY ABANDONED ANIMALS AND TOO FEW ADOPTERS. IN 2023, 1,240 ANIMALS WERE ACCEPTED FROM THE PUBLIC AND OTHER SOCIETIES.
